Privacy policy

The Yoshida Dental Mfg. Co., Ltd. (hereinafter referred to as "Yoshida" or "we") handles personal information in accordance with the following policy.

1. Compliance with protection laws and regulations

We will comply with the "Act on the Protection of Personal Information", the "Act on the Use of Numbers to Identify a Specific Individual in Administrative Procedures" and other related laws and regulations, as well as establish rules regarding personal information, and disseminate such rules to our officers and employees and other related parties, whereby we will handle personal information appropriately.

2. Security management measures for personal information

We will take necessary and appropriate safety management measures to prevent leakage, loss, or damage of personal information.

In addition, we will provide necessary and appropriate supervision to employees and contractors (including subcontractors) who handle personal information.

3. Handling of personal information

We will use legal and fair means to obtain personal information and will not obtain such information in improper ways. Furthermore, we will inform the person who is the subject of personal information of the purpose of use and obtain consent, or will announce the purpose of use on our website.

4. Purpose of use of personal information

We will clearly define the purpose of use of all personal information in our possession, and will not use it beyond the scope necessary to achieve that purpose.

Based on the provisions of the "Act on the Use of Numbers to Identify a Specific Individual in Administrative Procedures", we will not obtain, use or provide to the third party the specific personal information, etc. for any purposes other than those permitted by such Act.

5. Provision of personal information to third parties

We will not provide the personal information of our customers which we obtained to a third party except with the consent of the person or in accordance with the provisions of applicable laws and regulations.

6. Disclosure / correction / suspension of use of personal information, specific personal information, etc.

When the person requests disclosure, correction, or suspension of use of personal information in our possession, specific personal information, etc., we will promptly respond in conformity with the purpose of the laws and regulation after the proper identity verification.

Purpose of use of the personal information

- 1. We will use personal information for business conducted by us or our group companies within the scope of the purpose of use (including related purposes) described below.

 - g) Provision, collection, and examination of academic information and other information related to our business
 - h) Provision, collection, and examination of information for business start-up support and management support
 - i) Notification and report based on laws and regulations and other rules
 - 2) Personal information regarding our business partners such as suppliers and wholesalers, creditors or debtors to our company, and those who are currently in a contractual relationship or creditors/debtors relationship related to our business. Personal information of those who were in such relationship in the past or are in the prior stage leading up to the establishment of such relationships.
 - a) Fulfillment of obligations or exercise of rights based on the contractual relationship or creditors/debtors relationship, or for related response
 - b) Provision and collection of information related to the contractual relationship or creditors/debtors relationship
 - c) Building new contractual relationships and creditors/debtors relationships
 - d) Management of transaction history
 - e) Notification and report based on laws and regulations, and other rules
 - 3) Personal information of the point of contact for public relations related, other points of contact for external business or officers and employees (including part-time workers and temporary workers; the same shall apply hereinafter) who are in charge of contacts for external business, and of those who contacted, consulted and had access in other ways to our website.
 - a) Correspondence to the consultation, contact, or access, and other communications

- b) Management of access history
- c) Notification or report based on laws and regulations and other rules
- 4) Personal information of shareholders (including those who were shareholders in the past)
 - a) Fulfillment of obligations or exercise of rights based on, or response to laws, and other rules such as the Companies Act.
 - b) Management of the shareholders within the scope necessary to execute the above
- 5) Personal information of officers, employees (including those who were officers and employees in the past) or their family members
 - a) Appropriate allocation of personnel in our corporate group and other personnel management, salary payment and other labor management
 - b) Welfare, safety and health management
 - c) Education and training
 - d) Notification and report based on laws and regulations, and other rules In addition, for individuals whose information related to names and contact information we legally hold, this information may be used for notifications and other communications from our company to the extent necessary to carry out our business, regardless of the abovementioned descriptions.
- 6) Personal information about applicants for employment
 - a) For examination and decision of acceptance and rejection
 - b) For contact related to acceptance or rejection
 - c) Notification or report based on laws and regulations and other rules
- 2. We will use specific personal information, etc. within the scope necessary to achieve the following purposes of use.
 - For office work for preparing payment records to be prepared in accordance with laws and regulations
 - 2) For office work for preparing withholding slips to be prepared in accordance with laws and regulations
 - 3) For notification of health insurance and welfare annuity insurance based on laws and regulations
 - 4) For other affairs related to specific personal information, etc. based on laws and regulations

Shared use

 - In the case of a statutory agent, documents that can confirm the right of representation such as a certified copy of the family register (original)
 - In the case of entrusting, attach the person's power of attorney (please affix a the registered seal thereon and attach the seal certificate (original))
- 5) We will reply to each request by mailing the reply to the address stated on the resident's card or seal certificate attached to the request sheet and send it by registered mail and restricted recipient delivery.

The response will be sent within one month from the receipt of the request, but please note that it may be delayed due to unforeseen circumstances.

- 6) Please note that we will not be able to respond to requests in the following cases.
 - a) If there is a deficiency in the requesting procedure (omission in the request sheet, error in the described manner or contents, the lack of necessary documents to be attached, or lack or unpaid fee, etc.)
 - b) When we can not confirm the identity of the person making the request being the person in the subject or the agent of such person.
 - c) When the requested personal information or specific personal information, etc. is not eligible as our retained personal data.
